Disseminating and Implementing the Gravity
Project's Data Standards for Public Health, Health
Systems, and Community Organizations
Grant Initiative Update

Partnership/Background Information

At the Annual Conference on August 22, 2022, Civitas Networks for Health announced that we signed a letter of intent with Health Level Seven® International (HL7®) and the Gravity Project® to collaborate on implementation and dissemination.





Gravity is an HL7 FHIR Accelerator and a national public collaborative that develops consensus-based data standards to improve how we use and share information on social determinants of health.





Funding to Support Implementation

On October 6, 2022, Civitas received an award from the Robert Wood Johnson Foundation to further the implementation and dissemination of Gravity Project social determinants of health (SDOH) standards.

The 12-month project which kicks off on November 1, 2022, will provide opportunity for shared learning, training and technical assistance, and in-person multi-stakeholder convenings.



Data request to support clinical research

Goal: To identify and partner with sites that can provide retrospective Electronic Health Record (EHR) and/or claims data of all patients that is inclusive of below-mentioned subset

- Patient cohort: Acute Coronary Syndrome suspect at time of ED presentation (defined as Index Event)
- Data range: Up to 3 years prior to Index Event Emergency Department (ED) encounter and up to 30 days past the ED encounter
- Outcome documentation that has confirmation the patient was followed/contacted up to 30 days after the ED visit to confirm if they did or did not have a MACE event post-ED visit
 - Major Adverse Cardiac Events (MACE 2 definition) occurred, to include either: AMI (all types including STEMI, NSTEMI or any other MI), CABG, PCI, Death (all causes)
 - Or MACE NOT occurred
- MACE outcome documentation source: either within the EHR or an external source, to be able to provide a yes
 or no if MACE occurred within 30 days and what the event was (STEMI, NSTEMI, etc.)

1 in 4


women experience depression after the birth of a baby, while **only 1 in 8** asks for help with that depression

Much Higher Mortality Rate

in the US than other developed countries

In the first week postpartum, severe bleeding, high blood pressure, and infection are the most common contributors to maternal deaths, while cardiomyopathy is the leading cause of late deaths

DEMONSTRATED EFFECTIVNESS

Washington

Deployed first in WA with MCOs, FQHCs, and hospitals. One analysis found those participating in the program saw a **54.6% decrease in ED utilization** by their pregnant patients.

Idaho


A Blue Cross plan care manager received notification on a member who delivered twins out-of-state. Mom was discharged but twins admitted to NICU. Not wanting to leave her babies, mom did not receive follow-up care. Because of persistent outreach with the mom, she finally saw a physician for follow up and a pulmonary embolism and other health complications were identified and resolved.

Postpartum care should be ongoing and not a single encounter with services and support tailored to each woman's individual needs




Assuring appointments are scheduled and delivered in a timely and informed manner after a woman has a hospital event during pregnancy or postpartum
