



### HEALTH EQUITY ANALYSIS

- Evaluates correlation between CO APCD claims data use/access measures and publicly available social factors data from the CDC and Census data
- Made possible through geocoding the CO APCD
- Results show strong correlation between adult access to care and ED visits and all social factors



### **Public Report Review Process**

- Public reports are determined in a number of ways:
  - Legislatively mandated
  - Determined through state partners/contracts
  - Requested by legislators, media, non-profits
- All public reports are reviewed by multi-perspective CO APCD advisory committee
- Feedback incorporated into methodology and user experience

# **Health Data Utilities**

To benefit the public and greater good

### **Health Information Exchanges**

Facilitate access to and retrieval of clinical data to provide safer and more timely, efficient, effective, and equitable patient centered-care.

\*Industry standard definition\*

### **Health Data Utility (HDU) Definition**

Are entities with advanced technical capabilities, known for community collaboration that provide health information across communities for treatment, care coordination, service delivery, and quality improvement for public health, health, and equity purposes.



#### Trusted Exchange Framework and Common Agreement (TEFCA) Enables the Next Level of Nationwide Network Interoperability


While there has been tremendous growth in network interoperability, there is much unfinished business

- Less well-resourced providers, behavioral health, LTPAC
- Public health
- Payers (government and commercial)

## Bringing it all Together
