




# **Gravity Overview**

#### **New 2023 Consensus Social Risk Domains**

 Consensus development of priority terms for Digital Access and Digital Literacy with the support of Kaiser Permanente

#### **Current**: "IQR Sprint" including:


- Consensus Utility Insecurity value sets with existing terminology (full Utility Insecurity build spring 2024).
- Guidance on how to apply Gravity screening best practices and Gravity Intimate Partner Violence and Elder Abuse value sets within IQR and NCQA Health Equity + Interpersonal Safety domain.

#### Gravity SDOH Clinical Care FHIR Implementation Guide (IG)

- Standard for Trial Use v2.1 (STU2.1) publication in August 2023
- July 2023 CMS HL7 Connectathon successful Proof of Concept test to determine social care supplemental benefits, leveraging Da Vinci IGs for FHIR-based APIs

# Why Standardize SDOH Data Capture?

## 80% of patient outcomes are predicted by social factors

As more social factor data is collected, the use of evidence-based tools and the application of data standards are critical for better patient care and enablement of data aggregation and sharing.

#### The Gravity Project has made significant strides with development, but SDOH standards have not yet been fully implemented across the health care, public health, and social care ecosystem.

Advancing implementation of these standards not only supports individual patient care, but also supports public health and policymakers who are implementing of programs and policies that advance health equity.


## **Informing Gravity Resources for Implementation**

**Strategic Goal:** Enable Health and Social Care organizations to effectively implement and test Gravity Project SDOH data exchange and terminology standards to ensure they better meet community needs.


